

IMPORTANT Covid – 19 Waiver Form for Sandy Lane Hotel

1. Covid-19 Risks and Preventative Measures Undertaken

1.1 As you know, the Covid-19 virus ("**Covid-19**") is a highly contagious disease which has been certified by the World Health Organisation as a pandemic. We can assure you that Sandy Lane Hotel Co. Limited (the "**Hotel**", "**we**", "**us**", "**our**") has put in place extensive measures for the protection of our guests and staff, including an ongoing cleaning and compliance regime, in order to make sure that you are safe throughout your stay with us. Due to the challenges seen globally in seeking to control Covid-19, despite all of these efforts to prevent the spread of virus being taken by the Hotel and others, the risk of exposure to the Covid-19 virus anywhere, including while staying at the Hotel, cannot be fully eliminated. Full details of the cleaning and compliance regime undertaken by the Hotel are available on request.

2. Acknowledgement

2.1 By proceeding with booking and submitting the results of health screenings required by the Ministry of Health and Wellness of Barbados to the Hotel, I acknowledge that I, together with my travelling party and any of my visitors (each a "**Guest**" and collectively the "**Guests**") are aware of the symptoms of Covid-19. I confirm that none of the Guests are currently experiencing any symptoms of Covid-19. Within the past 14 days, no Guest has had or been advised to have a test for Covid-19 (other than as required for travel), no Guest has been advised to self-isolate and no Guest has any reason to suspect exposure to Covid-19.

2.2 I also acknowledge on behalf of each of the Guests, the contagious nature of Covid-19 and voluntarily acknowledge the risk that any of the Guests could be exposed to or become infected by Covid-19 during the time of their stay at the Hotel. Despite all of the extensive efforts taken, exposure to Covid-19 cannot be eliminated and I understand that should I or any of the Guests contract Covid-19, it may result in personal injury, illness, permanent disability and in extremely severe cases, can even be fatal. Each Guest is willing to accept sole responsibility for any such risk to themselves and/or their dependents (including, but not limited to any illness, injury, loss of work, loss of wages, emotional distress or medical expenses) resulting from or in any way connected to exposure to Covid-19 during the time of their stay at the Hotel.

3. Release and Waiver of Claims Against the Hotel

- 3.1 Except as set out in 3.2 below, I confirm that each Guest releases, covenants not to sue, discharges, and holds harmless the Hotel, its employees, agents, and representatives, of and from any and all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to exposure to Covid-19. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Hotel, its employees, agents, and representatives, whether a Covid-19 infection occurs before, during, or after our stay at the Hotel.
- 3.2 Nothing in this form shall exclude liability of the Hotel for death or personal injury caused by the negligence of the Hotel or its employees.
- 3.3 I confirm that I have explained the contents of this form to the Guests that I am entitled to confirm on behalf of all of them that the Guests agree to the acknowledgements and representations, the release and waiver, as set out in this form and to accept all these terms on behalf of them all. Such acknowledgement and acceptance is demonstrated by making the reservation and providing any required test results to the Hotel.
